Wyoming: New Law Increases Business Property Tax Exemption and Enacts Fair Market Value Limitations on Certain TPP

S.F. 48, signed by gov. 2/24/25; S.F. 49, signed by gov. 2/24/25. Effective January 1, 2026, new law increases Wyoming's "*de minimis*" business property tax exemption threshold by exempting the first \$75,000 in the fair market value of business property from taxation in each county rather than the first \$2400. Another recently signed bill enacts fair market value limitations on certain tangible personal property – providing that once such tangible personal property "reaches the depreciation floor, the trending factor shall remain constant for subsequent years until the property is removed from service." The legislation defines "depreciation floor" as 20% of the reported installed cost of the property. Please contact us with any questions.
